

Q1 How do you intend to implement the modules within the university curriculum?









It is advisable for the project team to think in advance and identify potential sources of funding in the future. And so, to maintain the sustainability of the project following the completion of European funding, the following steps will be taken: 1. Financial aspect. 2. Organizational aspect. 3. Business continuity. 4. Multiplicativity. Financial sustainability is determined by the possibility of further funding after the end of the project. This is where the project team can seek various acceptable funding sources. This can be either an agreement with the business sector in need of services / products provided as a result of the project, or a guarantee of local government on the allocation of budgetary funds, or financial resources of the university itself. Business continuity is seen as the viability of the project after funding is complete and the potential to implement the project's intended tasks and functions after the end of the project. The multiplicativity of the project means that the control effects have the property of multiplication, not addition. Multiplicativity should be understood as the multiplication of the efficiency of the system due to rational management actions (introduction of new technologies, know-how, improvement of the motivation system, leadership style, creation of new organizational structures, etc.). It can also be reflected in the impact of the project on the activities of the expanded group of target consumers and other stakeholders.
